Pacer Technology Bondini Brush-On Remover Gel (BGR) is an acetone-based thickened glue remover which is easily applied and does not run or migrate on the glue surface. Best for use on Super Glue and other instant glue products.

- Removes glue from skin
- Breaks glue bonds
- Cleans up excess glue
- Will not drip

PROPERTIES: Appearance: Clear thickened gel with ketone odor.

USE INSTRUCTIONS:

1. Protect clothing and work surfaces (metal foil works well).
2. Apply remover directly to adhesive/glue area. Allow sufficient time to penetrate and then begin rubbing, brushing, or sanding off softened adhesive.
3. Thick build-ups may require repeated application and physical removal (see step #2). Use razor blade or hobby knife to lift edges of cured adhesive and help removal process.
4. For removal from skin (do not use product near eye area), apply remover and gently peel adhesive off with fingernail. Reapply if needed.
5. Close bottle securely after use.

NOTE – Product may attack some plastics. Test first.

STORAGE AND SHELF LIFE

Store in cool area away from sunlight or heat. Stored under these conditions, a one-year shelf life can be expected.
