**Super Glue (bottle)**

Pacer Technology Super Glue (bottle package) (SGP3, SGP33, SGPM3, 151118, 19108) is a quick-setting adhesive that bonds strongly and works best on:

- Metal
- Rubber
- Most Plastics
- Aluminum
- Ceramic
- China
- Wood
- Pottery
- Jewelry
- Fingernails

**NOTE:** Not for use with Teflon, polyethylene, polypropylene, certain silicone rubber types, glass, rear view mirrors or parts that are subjected to great shock or continuous immersion in water. Not for porous materials such as paper, fabric or foam rubber.

**USE INSTRUCTIONS:** NOTE: For best results, surfaces should be clean & dry and parts should mate well.

1. Protect clothing and work surfaces (metal foil works well). Use in a well-ventilated area. Keep bottle pointed away from face and body. Carefully open by unscrewing cap while keeping bottle pointed away from face.
2. Apply to one surface, using 1 drop per square inch of surface. Do not spread glue with fingers – use applicator nozzle tip. Assemble parts and hold together with pressure for 15 seconds or until set.
3. Wipe tip if adhesive has accumulated before resealing cap securely.
4. Fingernail repair: Clean and dry nail thoroughly. Apply 1 drop of glue & spread over repair area with nozzle tip. Do not use if nail is inflamed or infected.

**STORAGE AND SHELF LIFE:** Replace cap and store upright in a cool area away from sunlight or heat sources. Stored under these conditions, a one-year shelf life can be expected.

**SAFETY AND HANDLING PRECAUTIONS**

Contains cyanoacrylate. CAUTION: Eye Irritant. Bonds skin & eyes in seconds. Use with adequate ventilation. Avoid contact with clothing as can cause burn. In case of eye contact, flush with water for 15 minutes; get medical attention for eye or internal contact. To remove from skin, soak in acetone nail polish remover & gently peel adhesive off with fingernail; water exposure will wear off residual adhesive in a few days (do not use polish remover around eye area). **KEEP OUT OF REACH OF CHILDREN.**
